Seven (7) White or Black Crappie Stringer			
All Entrants MUST adhere to All Rules and Regulations pertaining to Crappie Fishing within the boundaries of Lake Texoma.			
One pound (1) deduction for dead fish at weigh-in.			
All fish MUST have come from Lake Texoma proper			
Fishing is allowed from a boat, from the bank or from a boat slip. <i>If you have the proper permission from the slip owner.</i>			
All fish are a minimum of 10" in length			
It is OK to trailer to/from Big Mineral Resort & Marina. However fishing may not commence until 7:59, April 6th, 2024			
Only One (1) rod per person at a time in the water.			
Must be In Line at Weigh-In, No Later than 3pm			
All licensed Fishing Guides are EXCLUDED from entering / coaching and/or guideing for this tournament.			
Lake Texoma is Offlimits to Jr. & Sr. Anglers 4 days prior to the tournament 4-2-2024			
ALL Winners are subject to a polygraph test before payout.			
Law Enforcement from the Texas Parks & Wildlife will conduct or monitor the weigh-in.
